



## Ways to Fulfill CAP's Continuing Competency Program Requirements Through PAA

### The College of Alberta Psychologist's Continuing Competency Program

- Required for all regulated CAP members
- From April 1 to March 31 of every year, members must engage in and document competence activities at the following minimums:
  - 8 hours in **Professional Knowledge and Practice** -- *psychologists maintain awareness of published advances in theory, practice, and empirical research.*
  - 8 hours in **Ethics and Jurisprudence Knowledge and Practice** -- *psychologists maintain awareness of published advances in theory, practice, and empirical research.*
  - 8 hours in **Professional Engagement** -- *psychologists connect with other psychologists and others on a routine basis to foster and instill a commitment to both the profession and the practice of psychology.*
- 4 hours within any of the above sections must be in Indigenous-focused training – *to gain cultural competence and improved cultural safety for clients through cultural safety and humility education or awareness. Can be self-directed.*
- Members must also provide a declaration of involvement in Wellness activities

CAP is not utilizing a CEC system to track hours; however, formal CEC opportunities count towards the defined competence areas. Members must count hours in the defined competence areas, and CEC hours are one way to fill CCP requirements. This resource list is separated by activities with and without defined Continuing Education Credits so that psychologists can make informed choices regarding their participation.

Please note that these PAA activities, both formalized CEC opportunities and otherwise, are not officially endorsed by CAP as meeting the CCP requirements. Rather, this list was compiled by PAA Staff to help aid psychologists who may be searching for PAA activities to better fulfill their CCP requirements.
